I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 2<sup>nd</sup> batch of 150 (one hundred fifty only) MBBS students at Ayaan Institute of Medical Sciences, Teaching Hospital & Research Centre, Kanaka Mamidi, Moinabad Mandal, R.R. District, Hyderabad Telangana u/s 10A of the IMC Act, 1956 for the academic Year 2019-2020. 3. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.
4. Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.

The Board of Governors have also directed that the college authorities will submit an undertaking that they have corrected the deficiencies in infrastructure.
